

PRIVACY POLICY

Purpose

The website WWW.INCON-LOGISTIC.HU manages personal data for various purposes, while also respecting individuals' rights and relevant legal obligations. INCON-LOGISTIC International Logistics Consulting and Service Limited Liability Company, the operator of the WWW.INCON-LOGISTIC.HU website, considers it of utmost importance to inform concerned parties about the rules, methods, and key characteristics of managing the personal data obtained.

Basis for data management

We process personal data only for specific and legally justified purposes. These purposes and legal justifications are described in the individual data management information form.

In certain cases, we enlist external assistance or data controllers to manage personal data. The data controller may vary depending on the characteristics of each data management process. Principles we respect in data management

We manage personal data on the basis of all the applicable legal regulations. WWW.INCON-LOGISTIC.HU only manages personal data specified within the scope of individual data management. We protect the security of all personal data provided by all necessary technical and organizational measures. WWW.INCON-LOGISTIC.HU pays special attention to ensuring the confidentiality, integrity and availability of personal data. After you have provided your personal data, WWW.INCON-LOGISTIC.HU takes responsibility for its authenticity and accuracy.

We interpret the terms used herein as defined by Act CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information.

What are your rights regarding your personal data managed by WWW.INCON-LOGISTIC.HU?

You can request your data to be:

- **Modified:** You can ask us to modify your data through the contact details provided during the personal data management process.
- **Deleted or Blocked:** You can withdraw your consent at any time and request the deletion of your data if the data management process is based on your consent. We will respond to your written or electronically submitted request (with your consent) within 25 days of receiving it. If we cannot fulfil your request due to certain legal reasons, we will inform you of the factual and legal reasoning. We will delete your personal data if the data management of such data is illegal, the purpose of data management has ceased, the specified period for data storage has expired, or if the deletion of such personal data is ordered by the court or the National Authority for Data Protection and Freedom of Information. We will block your personal data upon your request, or if it can be assumed that deletion would violate your legitimate interests based on available information.

You can request information:

You are entitled to receive information about the personal data managed by WWW.INCON-LOGISTIC.HU and the characteristics of data management throughout the entire period of data management, particularly regarding:

- The source of the data,
- The purpose, legal basis, and duration of data management,
- The name and address of the data controller, along with their activities related to data management,
- The legal basis and recipient of data transmission,
- Any possible data protection incidents.

Information will be provided within 25 days upon submission of such a request. Information about the same data can be requested free of charge once a year.

Violation authorities, investigative authorities, prosecutor's offices, courts, public administrative authorities, the National Authority for Data Protection and Freedom of Information, or other bodies may contact WWW.INCON-LOGISTIC.HU to request forwarding, viewing, or transferring such data based on the stipulations of the law. If such a body specifies the legal basis and the scope of such data accurately, we will provide them with the personal data that is absolutely necessary for their purposes.

Raising objection to data management.

If WWW.INCON-LOGISTIC.HU continues to manage your personal data to fulfil its legal obligations or assert the legitimate interests of WWW.INCON-LOGISTIC.HU or a third party after you withdraw your consent, you have the right to raise an objection.

You can submit your objection via the provided contacts. We will assess and respond to your request within a maximum of 15 days upon receiving your objection. If we fail to reply to your request, you are entitled to take your case to court to protect your interests.

Legal remedy

If there is any potential violation of rights related to the management of your personal data, you have two options: you can file a complaint with the National Authority for Data Protection and Freedom of Information, or you can take your case to the competent court.

Whose data do we manage?

Who do we transfer your data to?

We do not forward your personal data to anyone else. Your personal data is only released to meet our legal obligations or in response to officially and legally justified requests from any competent authority or official body.
